

FUSION50 \$50 DEPOSIT MATCH PROMOTION

The following terms and conditions shall apply to the Fusion50 \$50 Deposit Match Promotion (the "Promotion") being offered by Game Play Network, Inc. ("GPN" or "b spot") to certain account holders only.

1. Duration of Promotion. The Promotion shall commence on Sunday, June 16, 2019, at 12:00 a.m. Pacific Time and shall end on December 31, 2019, at 11:59 p.m. Pacific Time (the "Promotion Period").

2. Eligibility. To be eligible for the Promotion, an individual must be a new player who enters the Promo Code "**fusion50**" at the time the b spot account is created using the Fusion Gaming application via a Fusion Gaming physical device (a "Player").

3. Promotional Wagering Dollars. If a Player makes an initial deposit into his/her b spot account during the Promotion Period (a "Deposit"), b spot will credit his/her account in amount equal to the lesser of (a) the initial deposit, or (b) Fifty Dollars (\$50) (the "Bonus"). b spot will credit the Bonus to the eligible account holder's account promptly after the Deposit is validated, which may take up to four (4) business days from the time Deposit was made. If the Deposit is returned for insufficient funds or is reversed for any other reason, b spot will cancel the corresponding Bonus credited to your account. A Player may only qualify for this Bonus once during the Promotion Period.

(a) Wagering Requirement. After the Bonus has been so credited, you must place wagers equal to double the Bonus (the "Wagering Requirement") before you can withdraw any remaining Bonus balance and any resulting winnings. If you have not fulfilled the Wagering Requirement within thirty (30) days following the date on which the Bonus was credited to your account, the Bonus is subject to immediate forfeiture without notice and b spot will cancel the Bonus credited to your account.

(b) For any wager placed toward the Wagering Requirement, funds are first deducted from your account in the following order: (i) your existing winnings balance; then (ii) your existing cash balance (including the Deposit); and finally (iii) your existing bonus balance (including the Bonus or any other unused promotional credits in your account).

(c) If you wish to initiate a withdrawal prior to meeting the Wagering Requirement, you must contact Player Services by e-mail or telephone. In such event, (i) you will be entitled to withdraw only the unused portion of any deposit made into your account and/or any winnings balance not derived from the Bonus, (ii) you shall have no right to withdraw either the Bonus or any winnings derived from the Bonus, and (iii) both the Bonus and any resulting winnings will be forfeited. Of course, once the Wagering Requirement has been satisfied, you may withdraw any and all amounts in your account (subject to any other limitations as set forth in the b spot terms & conditions or the terms & conditions applicable to any other promotions).

4. General Terms. The b spot Terms of Use posted on www.bspot.com (the "Terms of Use") govern this Promotion and your use of the b spot Service (as defined in Section 1 of the Terms of Use). b spot may disqualify any person from this Promotion in the event that the person: (i) violates the Terms of Use; (ii) engages in fraudulent or deceptive behavior; and/or (iii) attempts to defeat or circumvent any of the promotional rules or restrictions. b spot may suspend, discontinue, or modify the Promotion at any time for any reason. b spot account holders are only eligible for one promotion in a given promotion period and may not take advantage of multiple promotions that cover the same or overlapping promotion period. An account holder eligible for this Promotion cannot transfer his/her eligibility to another account holder.
