NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: b spot \$250,000 Club Promotion (the “Promotion”) begins on or about **May 15, 2019**, at 12:00:01 a.m. Eastern Time (“ET”) and ends on May 14, 2021, at 11:59:59 p.m. ET (the “Promotion Period”). Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes sponsored by Game Play Network, Inc. d/b/a b spot (“GPN” or “Sponsor”) or CataBoom, LLC (“Manager”), the manager of the Promotion retained by GPN. By participating in the Promotion, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Manager, which shall be final and binding in all respects.

ELIGIBILITY: Only b spot account holders in good standing are eligible to participate. Employees, officers and directors of GPN, Manager, their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “Promotion Entities”) and the immediate family members, and/or those living in the same household of each are not eligible to participate in the Promotion. In addition, any person prohibited from opening an account or wagering with b spot pursuant to its Terms of Use or applicable law, and all persons on b spot’s self-exclusion list, are not eligible to participate in the Promotion. A b spot account holder eligible for the Promotion may not transfer his/her eligibility to another account holder. This Promotion is void where prohibited by law.

HOW IT WORKS: Each purchase of a wager package during the Promotion Period costing forty dollars (\$40) will automatically receive one entry in the Promotion. Players may also receive entries in the Promotion by activating special features that may periodically be made available. Any winner will be notified with instructions on how to verify his/her eligibility and claim the Grand Prize. All Grand Prize claims are subject to verification of eligibility.

At the time of each entry in the Promotion, the Sponsor’s computer will randomly generate one (1) number associated with said entry (the “Participant Number”). If the Prize Determination Number and the participant’s Participant Number match identically and in order, the participant will be a potential winner of the Grand Prize, subject to verification of eligibility and compliance with these Official Rules. If there is a potential Grand Prize winner, such Grand Prize winner will receive instructions on screen at the time of Grand Prize winner determination on how to verify eligibility and claim the Grand Prize

The use of any device to automate the entry process is prohibited and will lead to disqualification.

Each of Sponsor and Manager reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Promotion, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Promotion, or to annoy, abuse, threaten or harass any other person, and each of Sponsor and Manager reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted.
