

## **\$2.5K FOURTH OF JULY FIREWORKS TOURNAMENT PROMOTION**

The following terms and conditions shall apply to the \$2.5K Fourth of July Fireworks Tournament Promotion (the "Promotion") being offered by Game Play Network, Inc. ("GPN" or "b spot").

1. Duration of Promotion. The Promotion shall consist of two rounds (collectively the "Promotion Period"):
    - (a) The first round (the "Qualifying Round") shall commence on Tuesday, June 29, 2021, at 9:00 a.m. PDT and shall end on Friday, July 2, 2021, at 6:00 p.m. PDT, and
    - (b) The second and final round (the "Final Round") shall commence on Saturday, July 3, 2021, at 7:00 a.m. PDT and shall end on Monday, July 5, 2021, at 6:00 p.m. PDT.
  2. Eligibility. The following terms apply to this Promotion:
    - (a) An account holder must play My Wagers totaling at least one hundred dollars (\$100) in any b spot game during the Qualifying Round. Players who successfully complete that goal ("Qualified Players") will advance to the Final Round.
    - (b) The Final Round will consist of game play in one or more to-be-determined b spot games that will be announced via email, in our app and on our Facebook and Twitter pages during the Qualifying Round (individually or collectively, the "Final Round Game").
    - (c) Qualified Players that play My Wagers in the Final Round Game during the Final Round will be scored as follows: the cash winnings revealed by playing up to two hundred dollars (\$200) of My Wagers in the Final Round Game during the Final Round will be totaled and that total will determine each Qualified Player's score (the "Score"). Only the first two hundred dollars (\$200) in My Wagers played in the Final Round Game during the Final Round will count toward the Score. By way of example, if a Qualified Player plays fifty dollars (\$50) in My Wagers and reveals two hundred fifty dollars (\$250) in cash winnings in the Final Round Game during the Final Round, his/her Score will be two-hundred fifty dollars (\$250). If the Qualified Player plays one hundred seventy-five dollars (\$175) in My Wagers and reveals three hundred sixty dollars (\$360) in cash winnings in the Final Round Game during the Final Round, his/her Score would be three hundred sixty dollars (\$360). If a Player's total cash winnings during the Final Round are matched to an amount of My Wagers in excess of two hundred dollars (\$200), their Score will be calculated to include only those winnings associated with the first two hundred dollars (\$200) of My Wagers played in the Final Round Game during the Final Round. Qualified Players may continue to play other b spot games during the Final Round, but any cash winnings from such additional play will not be factored into the Score.
- The Qualified Players with the ten (10) highest Scores in the Final Round will win a bonus (the "Bonus") as follows:
- (i) First Place: one thousand dollars (\$1000), and
  - (ii) Second Place: five hundred dollars (\$500), and
  - (iii) Third Place: three hundred dollars (\$300), and
  - (iv) Fourth Place: two hundred dollars (\$200), and

- (v) Fifth Place: one hundred fifty dollars (\$150), and
- (vi) Sixth Place: one hundred dollars (\$100), and
- (vii) Seventh Place: seventy-five dollars (\$75), and
- (viii) Eighth Place: seventy-five dollars (\$75), and
- (ix) Ninth Place: fifty dollars (\$50), and
- (x) Tenth Place: fifty dollars (\$50).

The Bonus is subject to the Wagering Requirement as set forth below.

(d) In the unlikely event of an exact tie in the Score between two or more Qualified Players, the Bonus will be split between them as follows:

(i) If the top two (2) Qualified Players tie, they will split the combined First and Second Place prizes and will each receive a Bonus of seven hundred-fifty dollars (\$750). If three (3) Qualified Players tie for First Place, they will split the combined First, Second and Third Place prizes, with a one thousand, eight hundred dollar (\$1,800) Bonus divided evenly between them. If more than (3) Qualified Players tie for First Place, they will equally split a number of the combined top prizes equal to the number of tied Qualified Players. If more than ten (10) Qualified Players tie for First Place, they will split the total available prize pool of two thousand five hundred dollars (\$2,500) equally between them.

(ii) If the second and third place Qualified Players tie, they will split the combined Second and Third Place prizes and will each receive a Bonus of four hundred dollars (\$400). If three (3) or more Qualified Players tie for Second Place, they will equally split a number of the combined top prizes from Second Place and below equal to the number of tied Qualified Players.

(iii) If two (2) Qualified Players tie for Third Place, they will split the combined Third and Fourth Place prizes and will each receive a Bonus of two hundred fifty dollars (\$250). If three (3) or more Qualified Players tie for Third Place, they will equally split a number of the combined top prizes from Third Place and below equal to the number of tied Qualified Players.

(iv) Ties between the top Qualified Players will be managed following the pattern established above until the total two thousand five hundred dollar (\$2,500) prize pool has been awarded.

(e) b spot will credit the Bonus to the Player's account promptly after all Final Round scores are validated, which may take up to four (4) business days after the end of the Final Round. If a Qualified Player plays My Wagers during the Promotion Period that derive from a deposit returned for insufficient funds or reversed for any other reason, b spot will cancel any Bonus credited to that Qualified Player's account. Any determination made by b spot regarding each Qualified Player's Score is final.

3. Wagering Requirement. After the Bonus has been credited to a Qualified Player's b spot account, he/she is required to place wagers equivalent to the amount of the Bonus (the "Wagering Requirement") before withdrawing the Bonus and any resulting winnings from his/her account. If he/she has not fulfilled

the Wagering Requirement within ninety (90) days following the date on which the Bonus was credited to the Qualified Player's account, he/she will forfeit the Bonus and any winnings derived from the Bonus.

(a) For any wager placed toward the Wagering Requirement, funds are first deducted from the Player's account in the following order: (i) winnings balance (if any); then (ii) cash balance (if any); and finally (iii) bonus balance (from the Bonus or any other promotional credit).

(b) If a Player wishes to initiate a withdrawal prior to meeting the Wagering Requirement, the Player must contact Player Services by e-mail or telephone. In such event, the Player will be entitled to withdraw only his/her winnings not derived from the Bonus and/or any cash balance, and the Player shall have no right to withdraw either the remaining balance of the Bonus or any winnings derived from the Bonus, and both the Bonus and any resulting winnings will be forfeited. Of course, once the Wagering Requirement has been satisfied, the Player may withdraw any and all amounts in his/her account (subject to any other limitations as set forth in the b spot terms & conditions or the terms & conditions applicable to any other promotions).

4. Disputes. b spot reserves the right to interpret all questions and conditions in regard to the Promotion, and its decisions shall be final.

5. General Terms. The b spot Terms of Use posted on [www.bspot.com](http://www.bspot.com) (the "Terms of Use") govern this Promotion and your use of the b spot Service (as defined in Section 1 of the Terms of Use). b spot may disqualify any person from this Promotion in the event that the person: (i) violates the Terms of Use; (ii) engages in fraudulent or deceptive behavior; and/or (iii) attempts to defeat or circumvent any of the promotional rules or restrictions. b spot may suspend, discontinue or modify the Promotion at any time for any reason. The following persons shall not be eligible to participate in the Promotion: (i) any employee of b spot; (ii) any person prohibited from opening an account or wagering with b spot pursuant to the Terms of Use or applicable law; and/or (iii) any person on b spot's self-exclusion list.
